# **Privacy Policy**

This Privacy Policy ("Policy") applies to newbeginningshome.org, and New Beginnings Home ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include newbeginningshome.org. The Company's website is a non-profit site. ## **Collection of your Personal Information**
